## **Application of Excess Volume Rates in Table 4:**

Rates in Table 4 apply to volumes exceeding the quarterly volume minimums to any single terminal at Brecksville, Ohio, of any shipper whose shipments during a calendar quarter (see definition) meet both of the following criteria:

- (i) total long haul shipments on Buckeye Pipe Line Company, L.P. exceed 6,500,000 barrels, and
- (ii) total volumes shipped between all origins and any single terminal at Brecksville exceed 2,100,000 barrels.

Rates in Table 4 apply only to volumes in excess of the 2,100,000 barrel quarterly volume minimum. Rates in Table 1 or Table 3 apply to all volumes equal to or less than the 2,100,000 barrel quarterly volume minimum.

#### **Definitions:**

For the purposes of this tariff, the following terms will be defined as:

Calendar quarter: a three consecutive calendar month period beginning on the first day of January, April, July, or October.

Long-haul shipments: all volumes transported except those moving within a single facility or point of origin.
