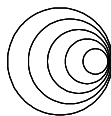

**Notes:**

- (1) Shipments to Avon, Indiana shall be limited to tenders consisting of fuel oil distillates corresponding to ASTM Grade 1-D or 2-D defined in ASTM designation D-974 as amended.
- (2) Transfer movements of Methyl Tertiary Butyl Ether (MTBE) at Lima, Ohio will be made for an additional handling charge of twelve and eight-tenths cents (12.8¢).
- (3) Notwithstanding any other limitations, shipments to Delmont, Pittsburgh, and Greensburg, Pennsylvania shall be limited to tenders of fungible batches of gasoline and low sulfur diesel. Product destined for Delmont, Pittsburgh, and Greensburg will be handled on a best efforts basis and will be accepted only when carrier can deliver corresponding fungible product tendered from other origins.
- (4) Deliveries to Jolietville subject to Capital Recovery Surcharge – see Table 2 on Page 3.

**Notes to Table 1: (Continued)**

(5) A Capital Recovery Surcharge of nine cents (9¢) per barrel will apply to the first three million (3,000,000) barrels delivered to the newly connected TE Products Pipeline Company, L.P. ("TEPPCO") terminal at Clermont, IN. This Capital Recovery Surcharge will apply to the Base Rates shown in Table 1 from all origin points. This Capital Recovery Surcharge will be discontinued when total deliveries from all origins to the TEPPCO Clermont terminal exceed three million (3,000,000) barrels.

**Application of Capital Recovery Surcharge in Table 2:**

The Capital Recovery Surcharge will apply to the first two million-eight hundred thousand (2,800,000) barrels (hereinafter referred to as "The Initial Minimum Volume Requirement") delivered to Jolietville, IN. The Initial Minimum Volume Requirement will be calculated by totaling all volumes delivered to Jolietville from any combination of the origins shown in Table 2. This Capital Recovery Surcharge will apply to the Base Rates shown in Table 1 until the Initial Minimum Volume Requirement is met. This Capital Recovery Surcharge will be discontinued upon attainment of The Initial Minimum Volume Requirement.

**Application of Incentive Volume Rate in Table 3:**

Rates in Table 3 apply to volumes of any shipper whose total shipments of specified product(s) between the origins and destinations shown during a calendar month equal or exceed the corresponding monthly volume minimum.

Rates in Table 1 apply to volumes of shippers not meeting the above criteria.

### Application of Excess Volume Rates in Table 4:

Rates will be determined based on the shipper's volume during a calendar month to each individual terminal at a given location or destination, specifically:

- (i) when the monthly volume delivered is less than the Monthly Volume Minimum, the Base Rate in Table 1 shall apply.
- (ii) when the monthly volume delivered is equal to or more than the Monthly Volume Minimum, the Base Rate in Table 1 shall apply to all volumes up to (but not including) the Monthly Volume Minimum, and the Excess Volume Rate shall apply to all barrels equal to or in excess of the Monthly Volume Minimum.

### Application of Excess Volume Rates in Table 5:

Rates will be determined based on the shipper's volume during a calendar month between the origin and destination shown, specifically:

- (i) when the monthly volume delivered is less than the Monthly Volume Minimum, the Base Rate in Table 1 shall apply.
- (ii) when the monthly volume delivered is equal to or more than the Monthly Volume Minimum, the Base Rate in Table 1 shall apply to all volumes up to (but not including) the Monthly Volume Minimum, and the Excess Volume Rate shall apply to all barrels equal to or in excess of the Monthly Volume Minimum.
