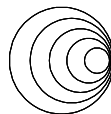

**Notes:**

- (1) Shipments to Avon, Indiana shall be limited to tenders consisting of fuel oil distillates corresponding to ASTM Grade 1-D or 2-D defined in ASTM designation D-974 as amended.
- (2) Transfer movements of Methyl Tertiary Butyl Ether (MTBE) at Lima, Ohio will be made for an additional handling charge of twelve and eight-tenths cents ● (12.8¢).
- (3) Notwithstanding any other limitations, shipments to Delmont, Pittsburgh, and Greensburg, Pennsylvania shall be limited to tenders of fungible batches of gasoline and low sulfur diesel. Product destined for Delmont, Pittsburgh, and Greensburg will be handled on a best efforts basis and will be accepted only when carrier can deliver corresponding fungible product tendered from other origins.
- (4) Volumes originating at East Chicago IL and destined for locations in ▲ Indiana, Michigan, Ohio, and Pennsylvania, may at the option of the carrier be transported via Norco Pipe Line Company, LLC from East Chicago, IN to Toledo, OH and then via Buckeye Pipe Line Company, L.P. to final destination.

### Notes (Continued):

- (5) A Capital Recovery Surcharge of nine cents ● (9¢) per barrel will apply to the first three million (3,000,000) barrels delivered to the newly connected TE Products Pipeline Company, L.P. ("TEPPCO") terminal at Clermont, IN. This Capital Recovery Surcharge will apply to the Base Rates shown in Table 1 from all origin points. This Capital Recovery Surcharge will be discontinued when total deliveries from all origins to the TEPPCO Clermont terminal exceed three million (3,000,000) barrels.
- (6) Volumes originating at Hartsdale, IN will be transported via Norco Pipe Line Company, LLC to Toledo OH, and then via Buckeye Pipe Line Company, L.P. to final destination, or via Norco Pipe Line Company, LLC to East Chicago, IN and then via Buckeye Pipe Line Company, L.P. to final destination. Selection of routing will be at the option of the carrier.

Rates in Table 1 apply to volumes of shippers not meeting the above criteria.

### **Application of Excess Volume Rates in Table 3:**

Rates will be determined based on the shipper's volume during a calendar month to each individual terminal at a given location or destination, specifically:

- (i) when the monthly volume delivered is less than the Monthly Volume Minimum, the Base Rate in Table 1 shall apply.
- (ii) when the monthly volume delivered is equal to or more than the Monthly Volume Minimum, the Base Rate in Table 1 shall apply to all volumes up to (but not including) the Monthly Volume Minimum, and the Excess Volume Rate shall apply to all barrels equal to or in excess of the Monthly Volume Minimum.

### Application of Excess Volume Rates in Table 4:

Rates will be determined based on the shipper's volume during a calendar month between the origin and destination shown, specifically:

- (i) when the monthly volume delivered is less than the Monthly Volume Minimum, the Base Rate in Table 1 shall apply.
- (ii) when the monthly volume delivered is equal to or more than the Monthly Volume Minimum, the Base Rate in Table 1 shall apply to all volumes up to (but not including) the Monthly Volume Minimum, and the Excess Volume Rate shall apply to all barrels equal to or in excess of the Monthly Volume Minimum.
