Product destined for Delmont, Pittsburgh, and Greensburg will be accepted only when carrier can deliver corresponding fungible product tendered from other origins.

(4) Joint Rate: Volumes originating at East Chicago IL and destined for locations in Indiana, Michigan, Ohio, and Pennsylvania, may at the option of the carrier be transported via Norco Pipe Line Company, LLC from East Chicago, IN to Toledo, OH and then via Buckeye Pipe Line Company, L.P. to final destination.
