### Special Products Handling Charge:

A special handling charge of seven and twelve hundredths cents (7.12¢) per barrel will be added for all unfinished or sub-grade gasolines including Reformulated Gasoline Blend Stock for Oxygen Blending (RBOB) and Conventional Gasoline Blend Stock for Oxygen Blending (CBOB).

### Linden Gulf Terminal Transfer Charge

Carrier will transfer gasoline, ULSD and heating oil only between it's Linden station and the Linden Gulf terminal (both in Union County, NJ) at the rate of thirteen and four hundredths cents (13.04¢) per barrel (42 United States gallons) destined for interstate commerce.

### Notes:

- (1) Distillate volumes will be handled on a best efforts basis.
- (2) Item No. 125 from FERC No. [W] 436.6.0 436.5.0 (Ultra-Low Sulfur Diesel Surcharge) does not apply.
- (3) Tariff rates indicated are under market-based rate authority in accordance with 18 CFR §342.4(b). All other tariff rates are non market-based rates.
- (4) For purposes of transportation under this tariff, the application of the term "line segment or facility" under Paragraph (A) of Item No. 90 of Buckeye Pipe Line Company, L.P.'s Tariff No. [W] 436.6.0 436.5.0, and any successors thereto, shall treat Lines 601 and 602 as a single "line segment."
