Section blanket approval in Docket No. FS92-4-000 issued July 15, 1992.

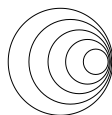

A special handling charge of six and sixty-four hundredths cents (6.82¢) per barrel will be added for all unfinished or sub-grade gasolines including Reformulated Gasoline Blend Stock for Oxygen Blending (RBOB) and Conventional Gasoline Blend Stock for Oxygen Blending (CBOB).
