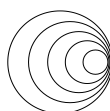

Application of Excess Volume Rate in Table 2:

Rates will be determined based on the shipper's total volume delivered between the origin and destination shown during the twelve calendar month period starting May 1, [W] ~~2018~~ 2017 and ending April 30, [W] ~~2019~~ 2018, specifically:

- (i) when the total cumulative volume delivered during the twelve month period is less than the Volume Minimum, the Base Rate in Table 1 shall apply.
- (ii) when the total cumulative volume delivered during the twelve month period is equal to or more than the Volume Minimum, the Base Rate in Table 1 shall apply to all volumes up to (but not including) the Volume Minimum, and the Excess Volume Rate shown in Table 2 shall apply to all barrels equal to or in excess of the Volume Minimum.
