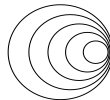
[C] Certain of the rates reflected in this tariff are being adjusted in accordance with the Commission's January 20, 2022 order in Docket No. RM20-14-001, which reduced the index for the current five-year review period from PPI-FG +0.78 percent to PPI-FG -0.21 percent (the "March 2022 Index"). To the extent that all or any portion of that order is reversed on rehearing or appeal and the index for the current five-year period is increased from the March 2022 Index level, Carrier reserves the right to collect from shippers the positive difference, if any, between the rates resulting from application of the March 2022 Index and the rates resulting from application of the new index, for all barrels shipped from March 1, 2022 forward.

The provisions published herein, if effective, will not result in an effect on the quality of the human environment.

Paulsboro to and from Colonial Junction

Carrier will transport Refined Petroleum Products through its pipeline facilities between Paulsboro and Colonial Pipeline Junction (both in Gloucester County, New Jersey) at the rate of [U] thirteen and seven hundredths cents (13.07¢) per barrel (42 United States Gallons) when same are moving in interstate commerce.

Paulsboro Terminal Transfer

Carrier will transport Refined Petroleum Products through its pipeline facilities from Paulsboro Plains Terminal to Paulsboro Sun Terminal or Buckeye Paulsboro Station (both in Gloucester County, New Jersey) at the rate of [U] fifteen and fifty-five hundredths cents (15.55¢) per barrel (42 United States Gallons) when same are moving in interstate commerce. An incentive discount rate will apply when Carrier transports Aviation Turbine Fuel through its pipeline facilities to Buckeye's Paulsboro Station at the rate of [U] four and fifty-two hundredths cents (4.52¢) per barrel (42 United States Gallons) when same are moving in interstate commerce.
