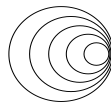

### **Paulsboro to and from Colonial Junction**

Carrier will transport Refined Petroleum Products through its pipeline facilities between Paulsboro and Colonial Pipeline Junction (both in Gloucester County, New Jersey) at the rate of [I] fourteen and twenty-one hundredths cents (14.21¢) per barrel (42 United States Gallons) when same are moving in interstate commerce.

### **Paulsboro Terminal Transfer**

Carrier will transport Refined Petroleum Products through its pipeline facilities from Paulsboro Plains Terminal to Paulsboro Sun Terminal or Buckeye Paulsboro Station (both in Gloucester County, New Jersey) at the rate of [I] sixteen and ninety hundredths cents (16.90¢) per barrel (42 United States Gallons) when same are moving in interstate commerce. An incentive discount rate will apply when Carrier transports Aviation Turbine Fuel through its pipeline facilities to Buckeye's Paulsboro Station at the rate of [I] four and ninety-one hundredths cents (4.91¢) per barrel (42 United States Gallons) when same are moving in interstate commerce.
