To the extent that all or any portion of that order is reversed on rehearing or appeal and the index for the current five-year period is increased from the March 2022 Index level, Carrier reserves the right to collect from shippers the positive difference, if any, between the rates resulting from application of the March 2022 Index and the rates resulting from application of the new index, for all barrels shipped from March 1, 2022 forward.

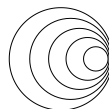

Application of Excess Volume Rate in Table 2:

Rates will be determined based on the shipper's total volume delivered between the origin and destination shown during the twelve calendar month period starting May 1, 2021 and ending April 30, 2022, specifically:

- (i) when the total cumulative volume delivered during the twelve month period is less than the Volume Minimum, the Base Rate in Table 1 shall apply.
- (ii) when the total cumulative volume delivered during the twelve month period is equal to or more than the Volume Minimum, the Base Rate in Table 1 shall apply to all volumes up to (but not including) the Volume Minimum, and the Excess Volume Rate shown in Table 2 shall apply to all barrels equal to or in excess of the Volume Minimum.
