 - Shipper must agree to transport a minimum of **[W]** 5,000,000 3,650,000 barrels of product **[C]** (combined from both origins) during a twelve month period (contract year).
 - [C] Once total volume exceeds 3,650,000 barrels in a contract year, the volume incentive rates from Lima to Columbus in Table 2 will apply to volumes in excess of the threshold.
 - [C] Once total volume exceeds 4,380,000 barrels in a contract year, the volume incentive rates from Toledo to Columbus in Table 2 will apply to volumes in excess of the threshold.

If a shipper fails to transport at least **[W]** 5,000,000 3,650,000 barrels during any contract year, a deficiency charge will be applied which will be equal to the then-current **[N]** incentive **[C]** gaseline rate from Lima to Columbus as documented in Table **[W]** 2 4 times the number of barrels deficient.
