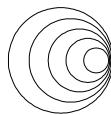

Application of Contract Rate in Table 2

The rate in Table 2 applies to qualifying shippers who commit to ship at least three million-three hundred thousand (3,300,000) barrels of Petroleum Products over a consecutive 12 calendar month period. Shippers may not combine volume with other shippers. To qualify for this rate, a Shipper must contract with Norco Pipe Line Company, LLC to ship the required amount prior to shipping same. For the purposes of application of this rate, "Petroleum Products" will include MTBE, toluene, raffinate, naphtha, natural gasoline buffer material, motor fuels and distillates.
