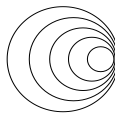

This exception applies to all pipeline transportation movements between the origins and destinations in the Table Of Rates.
- (2) Chicago Complex consists of the following locations: East Chicago, Lake County, Hartsdale, Lake County, and Lake George, Lake County. In this table, East Chicago is the applicable location.
