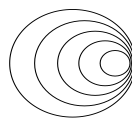

The Volume Incentive Rates are available to any shipper subject to the following conditions:

- (1) Shipper must agree to transport a minimum of 5,000,000 barrels of product during a twelve month period (contract year).

If a shipper fails to transport at least 5,000,000 barrels during any contract year, a deficiency charge will be applied which will be equal to the then-current incentive rate from Lima to Columbus as documented in Table 2 times the number of barrels deficient. Incentive rate applies to all barrels moved.

- (2) On a monthly basis, each shipper will be charged the base rate for volumes up to 150,000 barrels.

On a monthly basis, each shipper will be charged the incentive rate for all volume greater than 150,000 barrels.
