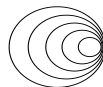

(2) Application of Rates:

When operating conditions permit, Buckeye Pipe Line Company, L.P. will transfer specified products through its existing manifold facilities to and/or from terminals, refinery tankage, and pipelines of any other company directly connected to Carrier's manifold facilities at the rate shown herein. For transfers in the Toledo, OH area, rate (A) shall apply to transfers of fungible products involving only the Carrier's manifold facilities; rate (B) shall apply to transfers involving its existing mainline pipes; rate (C) shall apply to aviation gasoline and other non-fungible products including any additional barrels of buffer material required to effectuate the movement.

(3) Toledo BP-Husky / Citgo Transfer Charge

Carrier will transfer products between the BP-Husky Toledo Refinery and the Citgo Toledo Terminal (both in Lucas County, OH) at the rate of **[U]** 12.90 cents per barrel.

The Volume Incentive Rates are available to any shipper subject to the following conditions:

- (1) Shipper must agree to transport a minimum of 5,000,000 barrels of product during a twelve month period (contract year).

If a shipper fails to transport at least 5,000,000 barrels during any contract year, a deficiency charge will be applied which will be equal to the then-current incentive rate from Lima to Columbus as documented in Table 2 times the number of barrels deficient. Incentive rate applies to all barrels moved.

- (2) Base rates set forth in Table 3 will be reduced by the applicable percent reduction based on the volume incentive level achieved by the Shipper during the 12 month period as listed in the table below. Rate Reduction % applies to all IPP and LPG barrels moved from Toledo to Lima and Lima to Toledo in the 12 month period that starts November 1 and ends October 31.
