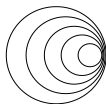

- (3) Exception to FERC Tariff No. 28.9.0 Item No. 45: A deduction of one-tenth of one percent (0.1%) will be made to cover evaporation, interface losses, and other normal losses during transportation.
- (4) Chicago Complex consists of the following locations: East Chicago, Lake County, Hartsdale, Lake County, and Lake George, Lake County. In this table, East Chicago is the applicable location.
