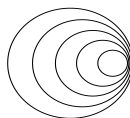

- (3) Shipments to Avon, Indiana shall be limited to tenders consisting of fuel oil distillates corresponding to ASTM Grade 1-D or 2-D defined in ASTM designation D-974 as amended.
- (4) Rates to Pennsylvania destinations are no longer subject to 18 CFR §342.4(b).
- (5) On a monthly basis, each shipper will be charged the base rate for volumes up to 130,000 barrels. On a monthly basis, each shipper will be charged the incentive rate for all volume greater than 130,000 barrels.
- [C] The Dearborn (Incentive) rate is unchanged from prior tariff FERC 443.42.1. This rate was posted in Table 2 of FERC 443.42.1, but has been moved herein to Table 1.

(1) The Volume Incentive Rate is available to any shipper subject to the following conditions:

Shipper must agree to transport a minimum of 5,000,000 barrels of product during a twelve month period (contract year).

If a shipper fails to transport at least 5,000,000 barrels during any contract year, a deficiency charge will be applied which will be equal to the then-current incentive rate from Lima to Columbus as documented in Table 2 times the number of barrels deficient.

Incentive rate applies to all barrels moved.
