Dear Secretary Chiavetta:

On April 2, 2024, Laurel Pipe Line Company, L.P. (“Laurel” or the “Company”) filed Tariff – Pa. P.U.C. No. 83 with the Pennsylvania Public Utility Commission (“Commission”). In this filing, Laurel proposed to add new Item No. 140 (Penalties for Late Changes to Nominations) that contemplates the assessment of a penalty to any shipper that changes its nomination after the nomination submission deadlines set forth in the tariff. On April 24, 2024, Laurel filed Supplement No. 1 to Tariff – Pa. P.U.C. No. 83, which voluntarily postponed the effective date of the tariff until July 1, 2024.

On June 6, 2024, Laurel filed a letter with the Commission that sought to make an administrative clarification to proposed Item No. 140. Consistent with the reasons set forth in its June 6, 2024 letter, Laurel has enclosed for filing a Replacement Tariff Page for Page 15 of Tariff – Pa. P.U.C. No. 83. Laurel is submitting a redline and clean version of this Replacement Tariff Page for ease of reference. The Company requests that the Commission’s order in this matter approve Tariff – Pa. P.U.C. No. 83, with the clarifications contained in the Replacement Tariff Page.
